**Summary of Prop G General Obligation Bond**

Proposition G is a \$247 million general obligation bond placed on the ballot by the Grossmont Healthcare District (GHD) Board of Directors, and passed by more than 77% of the voters on June 6, 2006. The approval of Proposition G authorized GHD to issue and sell bonds to provide projects consisting of the improvement, acquisition, construction and renovation of facilities for hospital and health care purposes on the Grossmont Hospital and District campuses. This includes projects specified in the Grossmont Hospital Facilities Master Site Plan.

**Accountability and Oversight**

In order to ensure that bond funds are spent in an efficient manner as outlined in Proposition G, the GHD Board of Directors desires that an effective and functional oversight committee be formed. The Independent Citizens’ Bond Oversight Committee (ICBOC) shall represent the community and be responsible to the GHD Board of Directors. The ICBOC is intended to provide accountability for expenditures made from Proposition G bond revenues. In addition, the ICBOC shall function in an independent and open manner to ensure that the intent of the voters as set forth in the measure is effectively implemented. The role of the ICBOC is to represent, advocate and promote the interests of the District residents.

The ICBOC shall meet in a public venue at least bi-monthly (every other month) for the first two (2) years at a regular date, time and location publicized to the general public in advance. Thereafter, the ICBOC shall meet at least quarterly. The committee shall establish standing committees to address specific issues.

It is important to note that the purpose of the ICBOC is to monitor and evaluate the expenditure of bond revenues on behalf of the public, not the design or management of construction projects.

The ICBOC will be established within 90 days of certification of the election results. The election was certified on June 29, 2006.

## **Eligibility/Public Interest Categories**

According to the ballot language, the ICBOC is to be comprised of at least nine (9) members, each member to be selected by the GHD Board of Directors through a public application process and to serve without compensation, to include:

- One member active in a taxpayers' organization
- One member active in a senior citizens' organization
- One member active in a business organization
- One nurse or physician

Additionally, after soliciting input from the community, the GHD Board adopted a resolution further refining the criteria for the ICBOC. All nine members must reside within the Grossmont Healthcare District. The intent is to have one member representing each of the specified areas of expertise (listed below). For each of these areas of expertise, an individual representing one of the region's colleges or universities with a comparable level of academic experience should also be eligible for consideration.

The ICBOC membership is to include:

### **At-Large Positions (3):**

One (1) individual from each of the following three (3) categories with extensive experience in:

- Project management – The chief executive officer or person in a similar senior-level decision making position, of a major private sector employer with demonstrated experience in leading a large organization.
- Large-scale construction operations – A professional with demonstrated experience of ten years or more in the management of large-scale construction projects.
- Finance – A professional in the field of municipal/public finance and/or budgeting with a minimum of ten years in a relevant and senior decision making position in the public or private sector.
